SPOTLIGHT: SSE07 Symposium

The International Symposium on Maritime Safety, Security and Environmental Protection (SSE07), which LMT is organizing and which will be held on September 20 and 21. 2007 in Athens, promises to be a top event.



Some 50 papers are scheduled to be presented, with speakers coming from many parts of the world. The Secretary General of the IMO Mr. E. Mitropoulos will deliver the keynote address of the symposium, which is under the auspices of The Hellenic Chamber of Shipping (NEE), the Hellenic Marine Environment Protection Association (HELMEPA), the Society of Naval Architects and Marine Engineers (SNAME), the International Association of Maritime Economists (IAME) and the World Maritime University's Journal of Maritime Affairs, which will serve as an outlet for papers presented at the symposium.

IMO: Psaraftis to coordinate MEPC correspondence group

Following the participation of Prof. Psaraftis last year at the 81st and 82nd sessions of IMO's Maritime Safety Committee (MSC 81 and MSC 82) as a member of the Greek delegation, this time LMT held center stage at the 56th session of IMO's Marine Environment Protection Committee (MEPC 56) that took place in London in July 2007.

Greece's submission to MEPC 56 dealt with environmental risk evaluation criteria in Formal Safety Assessment (FSA) and was prepared by Prof. Psaraftis and his former student Christos Kontovas. After discussion, the MEPC decided to form a

'correspondence group', coordinated by Prof. Psaraftis and tasked to further investigate the matter and report to the IMO in time for MEPC 57 (April 2008). The area of environmental risk evaluation criteria is important if one is to properly decide which risk control options are most cost-effective from an environmental viewpoint.

Presentation book coastal of shipping and cabotage

Some 150 people attended the presentation of the new book of Prof. Psaraftis entitled "Greek coastal shipping and cabotage", which took place late March at the premises of the Eugenides Foundation, the book's publisher.

Comments about the book were delivered by George Gratsos. President of the



Hellenic Chamber of Shipping, Michael Sakellis, President of the Union of Coastal Shipping Enterprises and Stratos Papadimitriou, Assistant Professor at the University of Piraeus. The 294-page book is bilingual (Greek and English), includes a collection of about 20 papers and articles written by the author from 1992 to 2006 and comments on developments in the sector of coastal shipping in Greece during this period. After the book presentation, a lively discussion on the status and

IAME 2007

LMT actively participated at IAME 2007, the annual conference of the International Association of Maritime Economists, which took place in July in Athens, Greece. Prof. Psaraftis delivered one of the keynote speeches of the conference, on the challenges of international waterborne transport. Also, three papers were presented, reflecting the research undertaken at LMT in the field of port financing, competition & investments in LNG shipping, and RFID technology in container transport (see section on papers for more details).


POP-C project

In late April, the final POP&C PMC meeting was held in Brussels, Belgium. The objectives of this research project to formulate a risk-based methodology to measure the oil spill



potential of tankers and to develop risk-oriented passive pollution prevention and active post accident pollution mitigation and control frameworks. The main participation of LMT was focused on consequence- and risk- based assessment of post accident activities including the integration of advanced technologies, the study of the human factor and the analysis of onboard procedures. In effect, the LMT group identified weaknesses of the current Risk Index scheme. presented a list of efficient Pollution Control Options (PCOs), assessed the role of the crew (and of the onshore personnel)

from a safety pointof-view, elaborated quantified results from a number of studies case integrating simulation approach etc.



PhD thesis defense

The Ph.D. title was awarded on May 25, 2007 to Panayotis Zacharioudakis from LMT, who successfully defended his thesis entitled "Development of Decision Tools in Shipping". The research supervisor was Ass. Professor D.V. Lyridis of LMT.

Regarding the content of the thesis, FORESIM can generally be described as a simulation procedure applied in the shipping market. The procedure was developed in order to produce future freight rates realizations depended to the current state of the market. The procedure is the first to introduce the concept of generating freight rate realizations conditional upon the current or the preceding market states and of embedding explanatory and stochastic modeling. Therefore, it creates tool for acquiring quality information regarding the trend of the market taking into consideration unforeseen parameters as well as the present status of the market. The main applications of FORESIM are the following:

- Decision support for trading Future Freight Agreements (FFAs) and various shipping market derivatives;
- Chartering strategy spot or time charter, duration, etc.;
- Risk management for shipping investments, in combination with cash flow and Monte Carlo simulations providing distribution for financial variables;
- Estimation of financing risk, such as probability of default, etc."

Greek Shipping Awards 2007

Prof. Psaraftis will be again a member of the panel of judges for the Lloyd's List Greek Shipping Awards 2007 - he had previously chaired that panel in the 2004 contest. As in past vears, the award winners will be judged by an independent panel representing a cross-section of Greek shipping and composed of industry luminaries. This year's panel of judges also includes Nicos Efthymiou, president, Union of Greek Shipowners, Philip Embiricos, president, Bimco, Nick Fistes,
